3. Board members are expected to attend all board meetings, events and to support the society and its committees as required. Board members shall be prepared to commit sufficient time and energy to attend to board businesses.
4. Board of directors cannot change any decisions made in Annual General Meeting (AGM).
5. Board members shall avoid, in fact and in perception, conflict of interest and shall disclose to the chair, in a timely manner, any possible conflicts of interest.
6. In case of special situation which a decision have to be made and having an official meeting is not possible, all the board members shall follow the instructions given by the chair or in his-her absence the vice chair.
7. Board member's contributions to discussions and decision making shall be positive and constructive.
8. Board member's interaction in meeting shall be courteous, respectful, and free of animosity.
9. Board members shall adhere to the board's governance policies.
10. Board members shall not attempt to exercise individual authority or undue influence over the board.
11. Being a TCICS board member is a voluntary work; no board members should expect any compensation for such service.
